You may choose only the items you desire, however, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the Statement we provide, describing the funeral merchandise you selected.

- 1. Local Transfer of Remains to the Funeral Home**
 - A. Within a 15 mile radius of the funeral home^{350.}~~\$300.00~~
 - B. Transfer of remains to or from Bradley Field\$400.00

- 2. Embalming:** Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with a viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

4. Basic Services of Funeral Director, Staff, Overhead.....\$1975.00

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for direct cremation, immediate burials, and forwarding or receiving remains. It includes:

1. Staff available 24 hours daily to respond to the initial request for services.
2. Conferences with the family or its representative.
3. Advisement to determine desired services.
4. Obtain vital statistical information for required documents.
5. Sheltering remains for 4 days.
6. Coordinate funeral plans with clergy, cemetery, crematory, other third parties.
7. Preparation and filing of all necessary notices, authorizations and permits with government offices.
8. Follow up attention to details connected to the service.

In addition, this fee includes a proportionate share of basic overhead costs, such as compliance with infectious waste management regulations, employee safety regulations mandated by government agencies, general administration and record keeping.
