### **BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF .....\$1,995.00**

Our fee for basic services of funeral director and staff includes, but is not limited to, staff to respond to initial request for service; arrangement conference with family and responsible parties; arrangement of funeral; preparation and filing of necessary authorizations and permits; recording vital statistics; preparation and placement of obituary notice; and coordination with those providing other portions of the funeral, e.g., cemetery, crematory, vault companies, and others as required. Also included in this service are overhead expenses relative to our facilities such as professional licensing, legal and accounting fees, insurance, building and utility expenses, parking lot and grounds maintenance, taxes, equipment, furnishings, inventory costs, recordkeeping, and secretarial and administrative expenses.

### **EMBALMING .....\$785.00**

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with a viewing. If you do not want embalming, you have the right to choose an arrangement that does not require you to pay for it, such as a direct cremation or immediate burial without a viewing.

### **OTHER PREPARATIONS OF BODY .....\$350.00**

Includes basic sanitary preparation, hair dresser, makeup, dressing, and casketing.

(death certificates, permits, obits, cemetery fees, clergy, flowers, etc.) Depending on cemetery rules and regs., an outer burial container may need to be purchased for an additional fee. ## DIRECT CREMATION

This charge includes necessary paperwork, transportation from place of death to funeral home and from funeral home to crematory; basic staff services and sheltering deceased during the mandatory 48 hour waiting period. This charge does *not* include the crematory or medical examiner fees, or use of funeral home and funeral home staff for any crematory or visitation, public or private, prior to cremation. When a direct cremation is arranged, the crematory requires that the body be enclosed in a suitable, combustible container. The containers provided by us are of a corrugated composition material with a ply-wood bottom. This is also referred to as an alternative container. Alternative containers can also be made of fiberboard or solid pine wood construction. Prices below reflect funeral home charge only for above itemized services, and do not include crematory charge (\$500.00), or a Saturday charge of \$550.00, or State Medical Examiner fee (\$200.00), both as of 9-1-19, or cost of death certificates, disposition permit, obituaries, clergy honorarium services, or related church fees, cemetery and florist charges, etc.

**FORWARDING OF DECEASED TO A MEDICAL SCHOOL .....\$995.00**

Some medical schools pay by the mile. In addition to the removal charge the consumer is responsible for the difference.

**RECEIVING REMAINS FROM ANOTHER FUNERAL HOME .....\$3,890.00**

Includes use of funeral home facilities, professional services, hearse to and from other funeral home and use of hearse day of funeral.

**FORWARDING REMAINS TO ANOTHER FUNERAL HOME .....\$3,065 ~ \$3,115**

Includes transportation of deceased from place of death to funeral home, necessary staff services, securing required paperwork, air-tray enclosure approved by airline, transporting deceased to local airport (Albany, NY or Hartford, CT - \$325.00, Logan or Kennedy airport - \$510.00). This cost does *not* include hair dresser, cosmetology, dressing, use of funeral home or funeral home staff for any ceremony or visitation, private or public, prior to burial.
