



## General Price List

(Effective January 7, 2022)

The prices and services shown below are those we can provide to our customers. You may select only the items you desire. However, any funeral arrangement you select will include a charge for our basic services and overhead. If legal or any other requirements mean you must buy an item that you did not ask for, we will explain the reason in writing on the disclosure statement that we provide in describing the funeral goods and services you selected.

Due to the requests of cemeteries, churches and the clergy, we ask that you provide the monies for the cemetery opening of the grave, or the purchase of the grave and church services in advance. These checks should be made payable to the respective church or cemetery.

### **BASIC PROFESSIONAL SERVICES OF FUNERAL DIRECTOR AND STAFF \$2,320**

This is the basic charge to each family which we service, for our professional expertise in assisting them. It includes, but is not limited to, a proportionate share of the taxes, licenses and business expenses necessary to serve the public in a professional manner. Also included in this charge is the consultation with the clergy, cemetery, crematory or common carrier, planning the funeral or memorial service, and placement of obituary notices. There will be an additional charge for the direction and supervision of each service requested or required. This fee, for our basic services and overhead, will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremation, immediate burials and forwarding or receiving remains.)

### **EMBALMING**

**\$910**

Embalming is not necessary by law. It is necessary however when the services selected include a public viewing or other extenuating circumstances, such as transporting on a common carrier. If you do not wish to have embalming occur, you have the right to choose an arrangement that does not require you to pay for it, such as a direct cremation, Green Burial or immediate burial. Families may choose the Green Embalming process that would utilize eco-friendly embalming fluids to help protect the environment.

### SUPPLEMENTAL SERVICES

#### DIRECT CREMATION

**\$3,350**

Charge for direct cremation includes:

1. The transfer of the deceased to the funeral home, services of our staff, washing, dressing, and placement in casket or alternative container selected using a biohazard OSHA approved pouch, crematory fee and holding. (**MA Law requires a 48-hour waiting period before cremation can occur**)
2. Transportation to the medical examiner and the crematory for examination and cremation.
3. Filing of all paperwork (death certificate, cremation authorization, burial permit, etc.) and composing and submitting an obituary notice if applicable.

**Services not included:** Medical Examiners fee, embalming, urn, casket, alternative container, or any cash advances such as obituary notices, certified copies of the death certificate, burial permit, etc.

**We would like cremated remains to be buried or returned to the family within 7 days. Toomey-O'Brien will not be legally responsible for cremated remains after 7 days past cremation.**

### IMMEDIATE BURIAL

\$2,690

Charge for immediate burial includes:

1. The transfer of the deceased to the funeral home
2. Washing, dressing, and placement in the casket selected
3. The necessary authorizations (including burial permit) services of staff, and local transportation to cemetery.

**Services not included: Casket and vault, use of facilities, service and cemetery charges.**

### GREEN BURIAL

\$2,690

This is very similar to the Immediate Burial above, but all burial containers are biodegradable and approved by the Green Burial Council. Also, vaults would not be used for this service. Green or Natural Funerals and Burials enables us to care for our dead with the least possible environmental impact. Service choices are incorporated in our General Price List and burial containers are available on our Casket Price List.

**Services not included: Biodegradable burial container, use of facilities, service and cemetery charges.**

### FORWARDING OF REMAINS TO ANOTHER FUNERAL HOME

\$1,825

Service for forwarding of remains includes professional services, removal, paperwork, embalming and transfer to the airport, within a 20-mile radius.

**Services not included: Casket, alternative container or shipping unit; visitation or viewing; service; merchandise; cash advances of other funeral home charges or any additional services.**

### RECEIVING OF REMAINS FOR IMMEDIATE DISPOSITION

Charge for receiving remains includes:

### EXTENDED SHELTER OF REMAINS

(Applicable when remains are held in excess of 3 days)

### TERMS OF PAYMENT

Toomey-O'Brien Funeral Home would appreciate payment in full on or before the day of the funeral. If this cannot be accomplished, then full payment is due **30** days from the date of the funeral. If payment is not paid when due, a late charge of **1.5%** per month (annual percentage rate 18%) **on the unpaid balance will be due.**

**In the event of default in payment, the person in charge, will pay reasonable attorney's fees and court cost in addition to any late charges applicable.**
