General Price List

These prices are effective January 1, 2021 and are subject to change without notice. The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Professional Services

Basic Services of Funeral Director and Staff **\$1695**

Our basic services charge includes but is not limited to 24-hour availability of funeral director and/or staff to respond to the initial request for services, arrangement conference with family or responsible party, arrangement of ceremonies, tribute and memorialization. Staff will advise, assist and recommend appropriate personalization and individualized ceremonies to commemorate the unique life of your loved one. This service charge also includes obtaining and recording vital statistics and biographical information; preparation and transmission of obituary notice; death certificate preparation, filing and obtaining necessary permits, authorizations, consents and assignments. Coordination with other parties such as hospital, doctor's office and staff, cemetery, crematory, clergy, and others involved in the services and disposition. Also included in this charge are overhead expenses relative to our facilities such as professional licensing, administrative services, insurance, maintenance, building and utility expenses, taxes, legal and accounting fees, record keeping, and equipment and inventory expenses.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for immediate cremations, immediate burials, forwarding or receiving remains, and other packaged funeral offerings as allowed by law.)

Embalming **\$800**

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as immediate cremation or immediate burial.

Special Restoration or Treatment of Remains, Additional Procedure(s) for organ/bone donors, or following an autopsy **\$250**

Other Preparation of the Deceased

- Dressing, Cosmetology & Placement of Decedent in casket or cremation container, **\$250**
- Bathing & Sanitary Care of deceased when no embalming has been performed **\$250**
- Refrigeration of unembalmed remains for a maximum of 72 hours. **\$175**

It is the policy of our firm to refrigerate an unembalmed patient after 4 hours in certain circumstances, such as family unavailability.

Staff Services, Facilities and Equipment

- A. Visitation at the Funeral Home or Other Facility (up to four hours) \$550**
Our services include visitation setup, display of floral arrangements, supervision and Attendants during the visitation, viewing or wake.
- B. Funeral Service at the Funeral Home or Other Facility \$650**
Our services include coordinating the funeral arrangement, supervision of the funeral, the ceremonies and the procession of the funeral, staff coordination and set-up at the facility for the funeral ceremony, supervision of committal or other disposition or service.
(If having Spring Burial, deduct \$100 from funeral fee and add the \$525 Spring Burial Fee)
- C. Memorial/Funeral Service with Visitation (same day) \$895**
Our services include coordination of the memorial service, set-up and display of floral Arrangements, supervision and staff for the visitation and for the memorial service, set-up and use of facilities for services.
- D. Memorial Service at Funeral Home or Other Facility \$650**
Our services include coordinating the memorial service, supervision of the memorial service, staff coordination of the ceremony, setup and use of facilities for the memorial service.
- E. Graveside Service \$550**
Our services include coordinating the graveside service, supervision of the graveside service, equipment and staff necessary to conduct the graveside service.
- F. Spring Burial Fee \$225**
Arrange for removal from winter storage, arrange and conduct committal services in the spring after the cemetery has re-opened. Applicable only when a full service funeral has occurred during the winter season. This fee includes the transfer vehicle.

Additional distance will be charged \$3.00 per mile
Evening Home Transfers (after 8 PM) and "extraordinary" circumstances add 125.00
- B. Hearse or Funeral Coach (within a 25-mile radius) \$525**
Additional distance will be charged \$3.00 per mile
An overtime fee applies after 4 hours at a rate of \$65 per hour
- C. Limousine (within a 25-mile radius) \$450**
Additional distance will be charged \$3.00 per mile
After 4 hours, there is an overtime fee of \$65 per hour
- D. Lead/Clergy/Flower/Errand Car (within a 25-mile radius) \$250**
Additional distance will be charged \$3.00 per mile
An overtime fee applies after 4 hours at a rate of \$65 per hour
- E. Transfer of deceased to Medical Examiner & Crematory \$395**
Additional distance will be charged \$3.00 per mile outside 25-mile radius

Special Packages

Forwarding Remains to Another Funeral Home **\$3970**

This charge includes the transfer of the decedent to our funeral home, limited basic services of staff, embalming, necessary authorizations, processing of paperwork, minimum shipping container, and transportation to Bradley International airport. This charge does not include the use of staff and facilities for visitation, rites or ceremonies, prior to forwarding of the remains. This charge does not include the cost of the casket, air tray or shipping charges.

Receiving Casketed Remains from another Funeral Home **\$2790**

This charge includes temporary shelter of remains, limited basic services of staff, and transportation of decedent to cemetery or crematory. This charge does not include the use of staff and facilities for visitation, rites or ceremonies, transportation from the airport or any other service or merchandise.

Receiving Cremated Remains from another Funeral Home **\$495**

This charge includes receiving cremated remains from family or via mail service delivery, temporary shelter of cremated remains, and limited basic services of staff. This charge does not include the use of staff and facilities for visitation, rites or ceremonies, or any other service or merchandise.

Immediate Burial **from \$2,845 to \$8,310**

This charge includes transfer of deceased to our funeral home, bathing and sanitary care of deceased in lieu of embalming, transportation to local cemetery, necessary authorizations and processing of paperwork, and limited basic services of staff. This charge does not include cemetery or government fees, the use of staff and facilities for visitation or ceremonies, refrigeration, or any other service, public or private, prior to burial.

Immediate Cremation

This charge includes the transfer of the decedent to our funeral home, bathing and sanitary care of deceased in lieu of embalming, transportation to local crematory, necessary authorizations and permits, basic services of staff. If you want to arrange an immediate cremation you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard and composition materials (with or without outside covering). The containers we provide are made of heavy fiberboard.

(BOTH SPRINGFIELD CREMATORY & HILLCREST CREMATORY REQUIRE A MINIMUM ALTERNATIVE CONTAINER TO SHELTER, HANDLE AND PROTECT REMAINS)**

This charge does not include crematory fee (350.) or Medical Examiner's fee (required, 100.) extended use of refrigeration (exceeding 48 hours from time of death), or the use of staff and facilities for visitation, rites or ceremonies, or any other service, public or private prior to cremation.
