The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF \$1975

Our fee for the services of funeral director and staff includes, but not limited to, staff to respond to initial request for service: arrangement conference with family or responsible party: arrangement of funeral: preparation and filing of necessary authorizations and permits: recording vital statistics: preparation and placement of obituary notices: staff assistance prior to, during and following the funeral, including coordination with those providing other portions of the funeral, e.g. cemetery, crematory and others. Also included in these charges are overhead expenses relative to our facility such as insurance, maintenance and utility expenses, secretarial and administrative cost, and equipment and inventory costs. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials and forwarding and receiving remains.)

EMBALMING \$575

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as a direct cremation or immediate burial.

USE OF FACILITIES AND STAFF FOR VIEWING/VISITATION \$675

Our services include set up of visitation area, placement of encased remains, display of floral arrangements, supervision of and attendance during visitation. Charges are per day or portion thereof.

USE OF FACILITIES AND STAFF FOR FUNERAL CEREMONY \$775

Our services include coordination the funeral arrangements, supervision of funeral and staff to attend the funeral ceremony.

USE OF FACILITIES & STAFF FOR COMBINATION WAKE AND FUNERAL SERVICE \$975

Our services include setup of visitation area, display of floral arrangements, coordination the funeral service arrangements, supervision of the funeral service and staff to attend the service.

Use of equipment and staff for Graveside Service \$450

Our services include accompaniment of the deceased to cemetery, supervision of graveside service and staff to attend service.

Our services include coordinating the funeral arrangements, supervision of funeral, and staff to attend the funeral ceremony
