*The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. **However, any funeral arrangements you select will include a charge for our services and overhead.** If legal or other requirements mean you must buy items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral services and merchandise selected.*

This list may not include prices for certain items you select, such as cemetery charges or crematory services, flower and newspaper notices. The estimates or final prices for those items will be shown on the itemized statement describing the funeral service and merchandise you selected. We charge you for our services in buying certain items.

ALTERNATIVE SERVICES: *The charges for direct cremations are burials include only the items listed in the following description.*

- A. Direct Cremation.....\$3,300-\$4,550**
1. With a Container provided by Purchaser.....\$3,300
 2. With an Alternative Container (Cardboard Container)\$3,500
 3. With a Cloth Covered, Wood Casket.....\$4,550

Our charge for a direct cremation includes local transfer of remains to the funeral home, required authorizations, services of the funeral director and staff, transportation of the body, by livery, to the local crematory and the return of the cremated remains to the funeral home. Transfer or other transportation by the funeral home livery beyond a radius of 20 miles is subject to an additional charge of \$6.50 per mile. If you want to arrange a direct cremation, you may use an unfinished wooden box or an alternative container. Alternative containers can be made of heavy cardboard, pressed wood or composition materials (with or without outside covering), or may be pouches of canvas or other materials. The direct cremation prices do not include the charge of the crematory or medical examiner.

- B. Direct Burial.....\$3,300-4,550**
1. With a Container provided by Purchaser.....\$3,300
 2. With an Alternative Container (Cardboard Container)\$3,500
 3. With a Cloth Covered, Wood Casket.....\$4,550

Our charge for a direct burial includes the local transfer or remains to the funeral home, required authorizations, service of the funeral director and staff minimal care of the deceased, transportation of the body, by livery, to the local area cemetery. Transfer or other transportation by the funeral home livery beyond a radius of 20 miles is subject to an additional charge of \$6.50 per miles. The direct burial prices do not include the charge of the cemetery and outer burial container, if required.

Transfer of Remains:

To the funeral establishment including personnel, equipment, and vehicle with a 20-mile radius.....\$450
 (\$6.50 per mile charge beyond local radius)

Preparation of Remains:

1. Embalming (including use of the preparation room)\$900
2. Embalming.....\$800
3. Use of Preparation Room.....\$100
4. Embalming (autopsied remains)\$1,250

In Massachusetts, embalming is not required by law. If you do not want embalming, you have the right to choose an arrangement which does not require you to pay for embalming, such as direct cremation or direct burial. If you select certain funeral arrangements, such as viewing or an open casket funeral, embalming may be required by the funeral home.

Other Preparation of the Remains: (excluding embalming)

Preparation of the remains, unless selected, is not required for direct cremation or burial.

1. Minimal Care.....\$500
For health and safety, minimal care includes bathing, hair washing, sanitization, setting of features, possible aspiration
2. Custodial Care (after 12 hours)\$125
Custodial care will not be charged on the days when embalming or other preparation of remains occurs, visitation is held or a funeral service is conducted.
3. Dressing/Casketing.....\$350
4. Cosmetology.....\$125
5. Restoration.....\$125 per hour
6. Repositioning and Care of Shipped in Casketed Remains.....\$250
7. Use of Preparation Room by Outside Group.....\$400

Arrangements.....\$2,850

Basic arrangements including funeral director, other staff, equipment and facilities, to respond to the initial request for service, the arrangement conference, securing of necessary authorizations and coordination of service plans with parties involved with the final disposition of the deceased. Also included in this charge are overhead expenses relative to our facility, such as insurance, building and utility expenses, parking lot and grounds maintenance, taxes, equipment, furnishings, inventory costs, recordkeeping and secretarial and administrative expenses.

The charge for our services will be added to the total cost of the funeral arrangements you select. However, this charge will not be added to the cost of a direct cremation, direct burial, forwarding of remains or receiving of remains because the process for those services includes this charge.

Limited Services:

Forwarding of Remains To Another Funeral Home.....\$3,350

This charge includes the transfer of the remains to the funeral home, embalming, staff services, securing necessary authorizations, and local transportation to point of shipment. The charge does not include shipping charges or additional items of services, merchandise, facility use, and livery that the customer may wish to select.

Receiving of Remains From Another Funeral Home.....\$3,550

This charge includes basic transportation of the remains to the funeral home and/or place of local disposition, staff services, and securing necessary authorizations. The charge does not include additional items of service, merchandise, facility use, and livery that the customer may wish to select.

Services and merchandise provided as cash advanced items will be billed at the same amount paid by the funeral firm.
