

# General Price List

These prices are effective July 14, 2022 but are subject to change without notice.

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

## Professional Services

### **Basic Services of Funeral Director and Staff** \$2395

Our basic services charge includes but is not limited to 24-hour availability of funeral director and/or staff to respond to the initial request for services, arrangement conference with family or responsible party, arrangement of ceremonies, tribute and memorialization. Staff will advise, assist and recommend appropriate personalization and individualized ceremonies to commemorate the unique life of your loved one. This service charge also includes obtaining and recording vital statistics and biographical information; preparation and transmission of obituary notice; death certificate preparation, filing and obtaining necessary permits, authorizations, consents and assignments. Coordination with other parties such as hospital, doctor's office and staff, cemetery, crematory, clergy, and others involved in the services and disposition. Also included in this charge are overhead expenses relative to our facilities such as professional licensing, administrative services, insurance, maintenance, building and utility expenses, taxes, legal and accounting fees, record keeping, equipment and inventory expenses. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for immediate cremations, immediate burials, forwarding or receiving remains, and other packaged funeral offerings as allowed by law.)

### **Embalming** \$895

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as immediate cremation or immediate burial.

### **Dressing, Placement of Decedent in casket/cremation container, and/or Cosmetology** \$395

### **Bathing & Sanitary Care of deceased, when no embalming has been performed** \$395

### **Refrigeration of unembalmed remains for maximum of 48 hours.** \$395

It is the policy of our firm to refrigerate an unembalmed patient after 4 hours.  
Refrigeration over initial 48 hour period: \$100 per day or part of the day

## **Staff Services, Facilities and Equipment**

Additional fee when services are schedule during the weekend of \$250 per service selected.

- A. Visitation at the Funeral Home or Other Facility (up to three hours) \$850**  
Our services include visitation and building setup, display of floral arrangements and other personalized, memorial items, supervision and attendants during the visitation, viewing or wake.
- B. Funeral Service at the Funeral Home or Other Facility \$850**  
Our services include coordinating the funeral arrangement, supervision of the funeral, the ceremonies and the procession of the funeral, staff coordination and set-up at the facility for the funeral ceremony, supervision of committal or other disposition or service.
- C. Funeral Service with Visitation (up to two hours prior same day, in succession) \$1495**  
Our service include coordination of the service at the funeral home or other facility, supervision of the funeral, the ceremonies, the procession of the funeral, staff coordination and set-up for the visiting hour(s) and service, at the facility for the ceremony, supervision of the committal of other disposition or service.
- D. Memorial Service with Visitation (same day, in succession—up to two hours of visitation) \$995**  
Our services include coordination of the memorial service, set-up and display of floral arrangements, supervision and staff for the visitation and for the memorial service, set-up and use of facilities for services.
- E. Memorial Service at Funeral Home or Other Facility \$595**  
Our services include coordinating the memorial service, supervision of the memorial service, staff coordination of the ceremony, setup and use of facilities for the memorial service.
- F. Graveside Service / Spring Burial \$595**  
Our services include coordinating the graveside service/spring burial, supervision, and staff necessary to conduct this service.
- G. Identification View (not combined with any other offering) \$395**  
Our service includes the set-up and space reservation for one family member to identify the deceased in an intimate setting, allowing he/she to confirm their identity (5-15 minute duration).

## Special Packages

### **Forwarding Remains to another Funeral Home** \$3995

This charge includes the transfer of the decedent to our funeral home, limited basic services of staff, embalming, necessary authorizations, and transportation to Bradley International Airport. This charge does not include the use of staff and facilities for visitation, rites or ceremonies, prior to forwarding of the remains. This charge does not include the cost of the casket, air tray or airline/shipping charges.

### **Receiving Casketed Remains from another Funeral Home** \$2990

This charge includes temporary shelter of remains, limited basic services of staff, and transportation of decedent from Bradley Airport to cemetery or crematory. This charge does not include the use of staff and facilities for visitation, rites or ceremonies, or any other service or merchandise.

### **Receiving Cremated Remains and/or Limited Basic Service Fee of Funeral Director & Staff when initial death is not cared for at our funeral home** \$895

Our limited basic services charge includes but is not limited to 24-hour availability of funeral director and/or staff to respond to the initial request for limited services, limited arrangement conference with family or responsible party, arrangement of local ceremonies, tribute and memorialization. Staff will advise, assist and recommend appropriate personalization and individualized ceremonies to commemorate the unique life of your loved one. Also included in this charge are overhead expenses relative to our facilities such as professional licensing, administrative services, insurance, maintenance, building and utility expenses, taxes, legal and accounting fees, record keeping, equipment and inventory expenses. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. Related to receiving cremated remains, this charge includes receiving cremated remains from family or via mail service delivery, temporary shelter of cremated remains. This charge does not include fees of staff and facilities for visitation, rites or ceremonies, or any other service or merchandise at funeral home or cemetery.

### **Immediate Burial** from \$3935 to \$18835

This charge includes transfer of the deceased to our funeral home, transportation to local cemetery, obtaining necessary authorizations and permits, and basic services of staff. This charge does not include cemetery or government fees, bathing and sanitary care of deceased in lieu of embalming, refrigeration, embalming, the use of staff and facilities for visitation, rites or ceremonies, or any other service, public or private, at the funeral home or cemetery, prior to burial.

### **Immediate Cremation** from \$3935 to \$8480

This charge includes the transfer of the deceased to our funeral home, transportation to local crematory, obtaining necessary authorizations and permits, basic services of staff, and refrigeration for up to 48 hours. This charge does not include crematory, medical examiner or government fees, bathing and sanitary care of deceased in lieu of embalming, refrigeration, embalming, the use of staff and facilities for visitation, rites or ceremonies, or any other service, public or private prior to cremation. If you want to arrange an immediate cremation you can use an alternative container or a casket. Alternative containers encase the body and can be made of materials like fiberboard and composition materials (with or without outside covering). The containers we provide are made of heavy fiberboard.
