**Itemized Selections**

The goods and services shown on this price list are those that we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead (minimum services of director and staff).

**MINIMUM SERVICES OF FUNERAL DIRECTOR AND STAFF ..... \$1,725.00**

This fee includes, but is not limited to:

- Personnel available to respond to calls 24 hours a day, 365 days a year
- Consultation with the family prior to, during, and after the arrangements conference
- Coordination of service plans with cemetery, crematory, clergy, and/or other parties involved in the final disposition of the decedent
- Preparation and listing of press releases
- Securing and recording vital statistics, as well as obtaining the death certificate and filing same with the appropriate agency

Also included in this charge are overhead expenses relative to our facilities, such as professional licensing, legal and accounting fees, insurance, building and utility expenses, parking lot and grounds maintenance, taxes, equipment, furnishings, inventory costs, record keeping and secretarial and administrative expenses.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This fee is already proportionally included in our charges for direct disposition services, forwarding and receiving of remains.

**EMBALMING ..... \$ 895.00**

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or direct burial.

## IMMEDIATE BURIALS .....\$5,075.00 to \$3,025.00

Our charge for an immediate burial, without any attendants' rites or ceremonies, includes removal and shelter of remains (local), sanitary care of remains, local transportation to the cemetery, and all necessary services of the director and staff. This type of disposition is done at the convenience of Graham Funeral Home and the cemetery involved. Scheduled arrangements require complete itemization.

## DIRECT CREMATION.....\$2,150.00

Our charges for Direct Cremations include removal of remains (local), sanitary care of remains, local transportation to crematory, and all necessary services of the director and staff. If you want to arrange a direct cremation you can use an alternative container. Alternative containers encase the body and can be of materials like fiberboard or composition materials (with or without covering). The containers we provide are either an unfinished particle board box, a wooden tray with cardboard cover, or some other container selected from our cremation selection room. This type of disposition is done at the convenience of Graham Funeral Home and the crematory. Should you desire a scheduled arrangement it is necessary for us to itemize your selections completely.

**PAYMENT AND POLICY TERMS**

A minimum deposit of 50% of the total funeral home charges and the sum of all cash advancements (if not paid directly to the provider by the family) is requested at the time of arrangements, it is required by the date of funeral service. The balance is due no later than 30 days from the date of initial arrangements consultation (*as noted on the Statement of Funeral Goods and Services Selected*). All balances unpaid after 30 days will be subject to a late charge in the amount of 1.5% per month. Filing of a claim on an estate does not remove nor change this policy.
