### GENERAL PRICE LIST

These Prices are effective as of January 1, 2024 but thereafter are subject to change without notice.

The following is an itemization of our General Price List, where each of our professional services is listed with their respective cost. Since 1880, it has been our personal and professional mission to offer our client families the highest level of service possible. We feel this is best accomplished by offering your family an experienced, compassionate and appropriately licensed staff all within an elegantly appointed facility which is designed to make you feel at home. The Sampson family and our staff honor the trust that you have placed in our care and will do everything within our means to see that your every expectation is not only met, but surpassed.

The goods and services shown on the next page are those that we can provide to our customers. You may choose only those items you desire. However, any funeral arrangements you select will include a charge for our services and operating expenses. If legal or other requirements mean that you must purchase any items you did not specifically ask for, we will explain in writing on the statement we provide describing the funeral goods and services you selected.

This list does not include prices for certain items that you may ask us to purchase or that may require us to purchase for you, such as cemetery or crematory services, or newspaper notices. The prices for those items will be shown on your bill or statement describing the funeral goods and services you selected.

#### Credit Policy

T.P. Sampson Company has established a uniform credit policy to serve all families fairly and avoid any misunderstandings. All financial arrangements must be completed before any public notice of funeral services or merchandise is furnished.

#### Payment Policy

- 1. CASH, BANK CHECK OR CREDIT CARD: In full at time of arrangements, to include full service funerals and cremations prior to publication of obituary and funeral service.**
- 2. ACCOUNTS PAID IN ADVANCE: Through a pre-arrangement contract.**
- 3. ASSIGNABLE INSURANCE: On the issue of insurance assignment, the beneficiary and death benefit must be determined in a timely manner and the insurance company must accept an assignment from the funeral home in order for our funeral home to accept such an assignment for payment. A processing fee of 6% will apply on all insurance assignments. Cash Advances must be paid.**

**NOTE:** Medical examiner cases may warrant non-acceptance of insurance if the cause of death is pending or under investigation even if the policy is verified and assignable. No policies less than two years old are assignable.

## Itemized Professional Services

**Basic Services of Funeral Director and Staff**..... \$2,971.00  
 Our professional service charges include, but is not limited to, personnel available on call 24 hours a day, consultation with family and clergy, arrangement and direction desired, procurement of obituary notices, preparation and filing of necessary notices, authorizations and consents, and other services and attendance prior to, during, and following funeral services, including coordinating with all outside parties that contribute to portions of services rendered such as casket and vault companies, cemeteries, or crematories.

**Embalming**.....\$960.00  
 Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not select embalming, you usually have the right to choose an arrangement which does not require you to pay for it, such as direct cremation or immediate burial. Aside from the actual embalming procedure, this fee includes the use of our state of the art preparation room that is in full compliance with federal EPA, OSHA, and medical waste mandates and standards. Additionally included is our experienced team of licensed embalmers to perform and oversee all matters pertaining to patient care.

## Service Options

**Use of Facilities for Visitation**.....\$1,188.00  
 This fee includes the use of the Funeral Home, arrangement and display of floral tributes, parking lot assistance, door personnel and professional supervision during visitation. This fee allows a maximum of four hours or a minimum of two hours per day.

**Funeral Service**.....\$1,178.00  
 This fee includes professional staff coordination and supervision of funeral ceremonies at the funeral home and/or church or other facility of your choice. Graveside service is included when the burial takes place on the same day.

**Morning of Visitation and Funeral Service (casket)**.....\$1,688.00  
 This fee represents two hours of visitation at the funeral home or other facility prior to a funeral service of the same day.

**Memorial Service (cremation)**.....\$1,688.00  
 This fee is applied for services at the funeral home or another facility where the deceased patient is not present or has been cremated. Our services include supervision and coordination of the memorial service, transportation and arrangement of floral tributes and memorial items.

**Graveside Service**.....\$976.00  
 This fee includes the supervision of the service, arrangement of floral tributes, and supervision of vault and grave closing. This fee only applies when a burial does not occur on the same day of a funeral service.

**Graveside Service of Cremated Remains**.....\$738.00  
 This fee includes the supervision of the service, arrangement of floral tributes, and supervision of the vault and/or grave closing. This fee only applies when a burial does not occur on the same day of a funeral.

**Saturday and Holiday Funeral Service**.....\$550.00

### Additional Services

**Forwarding of Deceased Patient to Another Funeral Home**.....\$3,198.00  
 This fee includes transferring the deceased patient from the place of death, basic services of the funeral director, embalming, basic shipping container, filing and securing of necessary authorizations and transportation to a local airport. This fee does not include any use of the facility or staff for viewing or ceremony prior to forwarding of the deceased. Please note that any transportation beyond a 15-mile radius will incur a fee of \$5.00 per transporting mile.

**Receiving of Deceased from Another Funeral Home**.....\$2,978.00  
 This fee includes transferring the deceased patient to the funeral home from the forwarding mortuary, temporary sheltering of the deceased, necessary staff services in coordinating local arrangements, transporting the deceased to a local cemetery or crematory and supervising of the final disposition. This fee does not include any use of the facility or staff for viewing or ceremony prior to the final disposition taking place.

**Immediate Burials** .....Range from \$4,368.00 to \$16,371.00  
 Our charge for an immediate burial with attendant funeral rites at a cemetery include transferring and sheltering of the deceased, necessary staff services in coordinating local arrangements, local transportation to a cemetery, and supervision of the interment process.

**Direct Cremations**.....Range from \$2,200.00 to \$10,813.00  
 If you desire to arrange a direct cremation, you may use an unfinished wooden box or an alternative container. Alternative containers may be made of materials, such as heavy cardboard or composition materials (with or without outside coverings), or pouches or canvas. Our charge for a direct cremation, with no attendant funeral rites or ceremonies, includes the transfer and temporary shelter of the deceased prior to the cremation, necessary staff services in coordinating local arrangements, and local transportation to the crematory.
