As Funeral Directors our calling imposes upon us a special responsibility to those we serve, and to the public at large, chief among them is the obligation to inform the public so that everyone can make knowledgeable decisions about the final arrangements of their deceased loved ones.

To help you understand..... It is your right, and our desire, that you have as complete of an understanding as possible regarding the cost of your services. The biggest factor is the time element in terms of our personnel and the use of the funeral home facilities. The maintenance of this service is unending; that is, it must be available 24 hours a day every year. Many phases of our work are apparent while others are not. It is important to realize that no two funerals are the same. Traditions, customs, social standing, personal feelings, financial ability and a multitude of other factors influence each funeral. Our services must conform to each individual family's wishes and their personal and religious needs.

Generally, Funerals are divided into five categories; Professional Services, Use of the Facilities, Merchandise, Cash Disbursements and Transportation. Each category is discussed in detail below.

Professional Services

Meeting with a family to secure vital statistical information, complete itemized cost agreement, select a casket and vault of their choice and oversee all aspects of the funeral. To coordinate times of the following services needed, Clergy, Fraternal Organizations, necessary automotive equipment for the convenience of the family, hairdresser, cemetery or crematory, vault company, veterans and civic associations. These services require an average of approximately 80 hours per funeral. The Funeral Director and Staff will aid the family. Completion of the Death Certificate with Vital Statistics, obtain signature and medical information from the attending physician or medical examiner, to file the completed and signed certificate with the register of vital statistics in municipalities where death has occurred and obtain burial permit and certified copies if possible. Completion of all necessary forms required by law. To answer all telephone calls and provide funeral information. The preparation and care of the deceased include embalming, shampooing, washing, shaving, dressing and casketing, application of cosmetics, hairdressing, arrangement of floral pieces, Funeral Director and Staff to attend and assist at all calling periods and funeral services.

Use of Facilities

Fixed overhead is calculated by the sum of all expenses per year divided by the number of services that were held each year. Included in the fixed overhead are the following: Taxes, Specialized Education, Surgical Supplies,

Services of Funeral Director and Staff **\$ 2,850.00**

Our Fee for the Basic Service of Funeral Director & Staff includes, but not limited to, personnel available 24 hours a day, 365 days a year, consultation with family and responsible parties before, during and after the arrangement conference, arrangement of funeral, preparation and filling of necessary authorizations and permits, recording vital statistics, coordination with those that provide other portions of the funeral (e.g., clergy, cemetery, crematory, vault company, and others as required. Also included in the charge are overhead

expenses relative to our facility, such as professional licensing, legal and accounting fees, insurance, building and utility expenses, parking lot and ground maintenance, taxes, equipment, furnishings, inventory cost, record keeping, and secretarial expenses.

Washing/Disinfecting of Remains (No Embalming) **375.00**

Embalming includes the use of a Massachusetts Registered embalming preparation room in compliance with the Federal EPA, OSHA, and most recent medical waste regulations. This fee also includes a Massachusetts Certified Embalmer to perform embalming procedure. Except in certain circumstances (i.e. delayed burial) embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with a viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as a Immediate Burial or Direct Cremation.
