ITEMIZED SELECTIONS

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF \$ 2500

Our fee for the basic services of funeral director and staff includes, but is not limited to, staff to respond to initial request for service; arrangement conference with family and responsible parties; arrangement of funeral; preparation and filing of necessary authorizations and permits; recording vital statistics; preparation and placement of obituary notice; and coordination with those providing other portions of the funeral, e.g., cemetery, crematory, vault companies and others as required. Also included in this charge are overhead expenses relative to our facilities such as sheltering of remains, professional licensing, legal and accounting fees, insurance, building and utility expenses, parking lot and grounds, maintenance, taxes, equipment, furnishings, inventory costs, recordkeeping, and secretarial and administrative expenses

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

EMBALMING \$ 1000

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing, if you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial. **Please note: If the body is to be held for longer than 50 hours the funeral will require embalming following state law.**

OTHER PREPARATION OF THE BODY

A. Reconstructive restoration when necessary (per/hour) \$ 200

G. Extended sheltering of remains (This per diem fee is charged beginning the 3rd day our facilities are used to shelter the remains) \$ 100

Our services will include set up of visitation, use of visitation room, placement of encased remains, display of floral arrangements, and supervision and attendance during the visitation for up to 2 hours..... \$ 800

Charge for each additional or part of a hour or morning of funeral..... \$ 350

B. Visitation at Other Facility
Our services will include local transportation of encased remains, set up of visitation, placement of encased remains, and supervision and attendance during visitation.

(1) One day visitation..... \$ 1000

(2) On-half day visitation.....\$ 600

C. Funeral Service at the Funeral Home.....\$ 1200

Our services include coordinating the funeral arrangements, supervision of funeral, staff to attend the funeral ceremony, supervision of committal or other disposition service, and set-up and use of facilities for funeral ceremony.

D. Funeral Service at Other Facility..... \$ 1000

Our services include coordinating the funeral arrangement, supervision of committal or other disposition service, and equipment and additional staff necessary to conduct funeral at other facility.

E. Memorial Service at Funeral Home.....\$ 800

Our services include coordinating the memorial service, supervision of the memorial service, staff to attend memorial service, and set-up and use of facilities for memorial service.

F. Memorial Service at Other Facility..... \$900

Our services include coordinating the memorial service, supervision of the memorial service, and additional staff necessary to conduct memorial service at other facility.

DIRECT CREMATION...\$ 3600

The charge for a direct cremation includes removal of remains, local transportation to crematory, necessary authorizations, and basic services of the staff. This

TRANSFER OF REMAINS TO FUNERAL HOME

Transfer of remains from hospital or nursing home.....\$ 850

Transfer of remains to Funeral Home from a private residence..... \$ 950

(Per mile charge for transfer outside the 25-mile service area around the funeral home) \$ 3

IMMEDIATE BURIAL...\$ 4000

The charge for immediate burial includes removal of remains, local transportation to the cemetery, necessary authorizations and basic services of staff. This charge does not include the use of facilities and staff for any visitation or ceremony, public or private, prior to burial.

A. Immediate burial with casket provided by the purchaser..... \$ 4000

B. Immediate burial with casket selected from our funeral home (in addition to cost of the casket.....\$ 4000

charge does not include the crematory fee or the use of facilities and staff for any visitation or ceremony, public or private, prior to the cremation. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are unfinished wood boxes and fiberboard boxes.

- A. Direct cremation with container provided by purchaser..... \$ 3600
- B. Direct cremation with fiberboard container selected from our funeral home...\$ 3900
- C. Direct cremation with casket selected from our funeral home (in addition to the cost of the casket) \$ 3600

FORWARDING REMAINS TO ANOTHER FUNERAL HOME

This charge includes removal of remains, basic services of staff, embalming, necessary authorizations, and local transportation to airport. This charge does not include visitation, rites or ceremonies prior to forwarding of the body.
