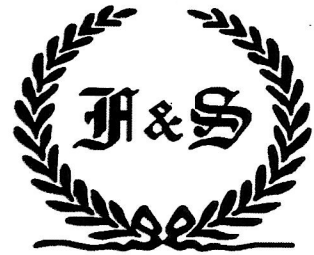

The estimates or final prices for those items will be shown on the itemized statement describing the funeral service and merchandise you selected. We charge you for our services in buying certain items.*

**ALTERNATIVE SERVICES:** *The charges for direct cremations are burials include only the items listed in the following description.*

*Our charge for a direct cremation includes local transfer of remains to the funeral home, required authorizations, services of the funeral director and staff, transportation of the body, by livery, to the local crematory and the return of the cremated remains to the funeral home. Transfer or other transportation by the funeral home livery beyond a radius of 20 miles is subject to an additional charge of \$6.50 per mile. If you want to arrange a direct cremation, you may use an unfinished wooden box or an alternative container. Alternative containers can be made of heavy cardboard, pressed wood or composition materials (with or without outside covering), or may be pouches of canvas or other materials. The direct cremation prices do not include the charge of the crematory or medical examiner.*

*Our charge for a direct burial includes the local transfer or remains to the funeral home, required authorizations, service of the funeral director and staff minimal care of the deceased, transportation of the body, by livery, to the local area cemetery. Transfer or other transportation by the funeral home livery beyond a radius of 20 miles is subject to an additional charge of \$6.50 per miles. The direct burial prices do not include the charge of the cemetery and outer burial container, if required.*

**Limited Services:**

**Forwarding of Remains To Another Funeral Home \$3,350**

This charge includes the transfer of the remains to the funeral home, embalming, staff services, securing necessary authorizations, and local transportation to point of shipment. The charge does not include shipping charges or additional items of services, merchandise, facility use, and livery that the customer may wish to select.

**Receiving of Remains From Another Funeral Home \$3,550**

This charge includes basic transportation of the remains to the funeral home and/or place of local disposition, staff services, and securing necessary authorizations. The charge does not include additional items of service, merchandise, facility use, and livery that the customer may wish to select.
