However, any funeral arrangements you select will include a charge for our standard professional services and overhead. This general price list does not include prices for certain items that you may ask us to buy for you (referred to as cash advances), such as cemetery or crematory services, flowers, newspaper notices and permit fees. The prices for those items will be shown on your statement describing the funeral goods and services you selected.

SERVICES OF FUNERAL DIRECTOR AND STAFF _____ \$1995.00

Our professional service charge includes, but is not limited to, 24 hour availability of staff to respond to initial request for services; consultation with family and clergy; arrangement and direction desired; preparation and placement of obituary notice; preparation and filing of necessary vital statistics, authorizations, consents, permits, and other services and assistance prior to, during and following the funeral including coordinating with those providing other portions of the funeral, i.e. cemetery, crematory, vault companies, and others as required. Also included in this charge are overhead expenses relative to our facilities such as insurance, maintenance and utility expenses, secretarial and administrative cost, and equipment and inventory expenses.

This fee for our professional services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremation, immediate burials, and forwarding or receiving of remains.)

EMBALMING _____ \$650.00

Embalming is a chemical process that provides temporary preservation of a human body and eliminates certain health hazards. A person licensed by the State of Massachusetts must complete this procedure. Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing or if services are scheduled more than fifty hours after the time of death.

OTHER PREPARATION OF THE BODY _____ \$295.00

This fee includes dressing and casketing, cosmetology, and washing disinfecting of remains and/or topical preservative prior to cremation. If embalming is not required, a protective pouch is included.

If you want to arrange a direct cremation, you can use an alternate container. Alternative containers encase the body and can be made of materials like pressed board or composition (with or without an outside covering). The containers we provide are pressed board containers.
